

## March 20, 2018 - RACOG Report

**NY Alerts Update** – Waiting to hear back from Jason Willetts after their management meeting yesterday. It currently looks like the new vendor will not support individual village and town users. Jason is checking into whether RACOG can be setup like a county organization within the NY Alert system. The other option will be to reach out to the county and see if they can setup user roles for each municipality for alerts. Other options besides NY Alerts are being looked at.

**LED Lighting** – There is a complete list of inventories for the LED lighting. Jamie Rogers the Clean Energy Communities representative from ANCA is willing to come out and meet with the group about next steps. It might also be worth seeing if Chris Carrick from the Central New York Regional Planning & Development Board could come speak to the group also.

The Environmental Finance Center has agreed to submit for that application and would handle the administration of that intern if successful.

**Mapping** – Village of West Carthage will be receiving a QGIS package with their data on it for the planning board. The village of Carthage DPW Superintendent on Thursday afternoon will be shown how to utilize the tablet and mobile application. Preparation for the culvert mapping project for town of Wilna will be starting soon.
