AmberLee Clement, Fort Drum Employment Readiness, discussed efforts by her agency to work with families transitioning to the local area who are looking for employment.

Brian Jackson, DOL Disabled Veteran Outreach, discussed efforts through the NYS Department of Labor to help all veterans with skill matching and employment placement. He encouraged businesses and municipalities to advertise vacancies through the Department of Labor. He also stated that 30-40% of separating and/or retiring service members stay in the area.

Lorrie Guler, Fort Drum Transition Services, discussed a mandatory program for all retiring/separating service members to provide employment information, financial planning, and benefits.

New Business

• M. Dietrich distributed a draft RACOG brochures. Members discussed various approaches to the brochure including a generalized information to support the area; a brochure to attract economic development, and; a brochure to document RACOG achievements and shared services as per the mission statement. B. Ferguson questioned the purpose of the brochure. W. McIlroy stated that he see the purpose of the brochure as information to distribute to new residents.
