



September 21, 2021 - RACOG Report

Presenters: Friends of the Black River – Ethan Pease (Fort Drum Intern)

Black River Trail/Railroad Bed – Have not heard much more on this front, other than the continued efforts to extend the trail to Fort Drum.

Black River Community Action Group – The Fort Drum intern has been working with historians and others to compile a list of historic sites along the Black River. The hope is to get out onto the river the first week in October to do the mapping work. GYMO has volunteered to do the mapping work. There have also been talks of having the historical information hosted on the blackriverny.com website.

Clean Energy Communities – ANCA has been working with communities on this initiative. Champion and West Carthage are going through Good Energy for their community choice aggregation and solar opt-in program. Lewis County has selected Joules Assets for their administrator for the program.

Walkable Communities (Complete Streets) – An extension was given to Jefferson Lewis BOCES until July 2022 to finish the complete street projects. A meeting will be setup soon with BOCES. Lewis County continues to work with communities on administering grant funds for projects that were selected as part of their Lewis County Walkability Institute. We also did have a meeting with the NYSDOT to discuss what types of things could be implemented along state highways in the future.

LED Lighting – Communities going through NYPA are closing right now with National Grid. Construction should be started by the end of September. It has been brought up whether the group wants to for an association or committee that will meet periodically about the LED lighting. The town of Champion and village of Castorland switched over with National Grid.

Fort Drum Internships – We currently have Ethan Pease working with us. He has been doing a great job and working hard on the Black River historical information.

Websites – Working on the town of Wilna website. Currently, the towns of Champion, Lowville, and villages of Castorland, Copenhagen, and Deferiet currently utilize the RACOG website service. The town of Denmark is looking into possibly switching over to the RACOG website service.
